Sukhipur Municipality, Office of Municipal Executive, Sukhipur, Siraha invites electronic bids from eligible bidders for the construction of **Construction of Saraswati Multiple Campus Building, Sukhipur Municipality-1, Mohanpur, Siraha** (Contract No: SM/W/20/2079/080) under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 5,75,00,000.00**
 - Minimum Work experience of similar size and nature: One project and value of each project NRs. 7,30,00,000.00
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB21 of the Bidding Document.

Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 29,00,000.00** which shall be valid for 30 days beyond the validity period of the bid.
